# PRIVACY POLICY HANDMADE DESIGNS, LLC.

This Privacy Policy, together with the Terms and Conditions of the site, and any amendments to such, governs your participation as a user (the "Client") of the website or associate websites, products or services associated with <a href="www.handmadedesigns.com">www.handmadedesigns.com</a> (the "Project"). The Client covenants and agrees as a condition precedent to accessing this website to be bound by this policy, and the schedules attached, as may be amended by Handmade Designs, LLC, ("HANDMADE DESIGNS") an Idaho Limited Liability Company, from time to time.

#### 1. PRIVACY POLICY

- 1.1. This statement sets out the privacy practices and policies of Handmade Designs, LLC ("HANDMADE DESIGNS") in relation to any information that you may share with HANDMADE DESIGNS in your capacity as a HANDMADE DESIGNS Client.
- 1.2. In this statement, when we talk about "HANDMADE DESIGNS" or "we" or "our", we are referring to HANDMADE DESIGNS, LLC, and its majority-owned or controlled subsidiaries.
- 1.3. HANDMADE DESIGNS reserves the right to update this policy from time to time, with no notice to you. Your continued use of any website or service covered by this policy after an amendment will constitute your agreement to the same.

#### 2. PERSONAL INFORMATION

- 2.1. HANDMADE DESIGNS will use your Personal Information to establish your Client account, to communicate with you, and for ongoing record keeping, as required by law.
- 2.2. HANDMADE DESIGNS will not release Personal Information about you except:
  - 2.2.1. as permitted in this Privacy Policy;
  - 2.2.2. as permitted in any written agreement between you and HANDMADE DESIGNS; and
  - 2.2.3. where we believe it is reasonably necessary to conduct business, fulfill a need, or otherwise assist you and your business.
  - 2.2.4. HANDMADE DESIGNS will provide a means for you to communicate your privacy questions and concerns to us.
  - 2.2.5. We will not knowingly collect Personal Information on users under the age of eighteen. We encourage parents and guardians to monitor the activities of their children and are in no way liable for a minor's use of this website.

#### 3. ANONYMOUS INFORMATION

- 3.1. "Anonymous Information" is information other than Personal Information, and includes the domain names, IP addresses and type of browsers that you may use, from time to time, referring URLs, and other, non-personally identifiable information.
- 3.2. HANDMADE DESIGNS can and will use IP addresses to identify users of our site when we feel it is necessary to enforce compliance with our site's Terms and Conditions, or to protect our service provide services or to assist our partners, advertisers or Funding Partners, site, or other users.

## 4. SHARING PERSONAL INFORMATION

- 4.1. We will not share your Personal Information unless required, and you have authorized us to do so.
- 4.2. ## 5. THIRD PARTY RELATIONSHIPS

- 5.1. You may find direct links from HANDMADE DESIGNS to third party websites. You may also find direct links from third party websites to HANDMADE DESIGNS. HANDMADE DESIGNS cannot guarantee that these sites have adopted acceptable privacy policies. - 5.2. 5.4. You will have the opportunity to opt out of any such transfer if the new entity's planned processing of your information differs materially from that set forth in this Privacy Policy.

### 6. SECURITY

- 6.1. HANDMADE DESIGNS operates secure data networks protected by industry standard firewall and password protection. HANDMADE DESIGNS has security measures in place to attempt to protect against the loss, misuse and alteration of your user data under our control. Unfortunately, no method of data transmission or storage is entirely secure, and while we make reasonable efforts to protect data stored on our networks, we cannot ensure or warrant the security of any information that you transmit to us, and you do so at your own risk.
- 6.2. Only authorized employees have access to the information you provide us.
